There is a loan administration fee of \$50 for all loans and a loan default fee of \$500 per loan. The loan application can be completed online or in person. All official legal loan documents will be completed in person at Pierce Pepin Cooperative Services physical location noted above. The maximum individual loan is \$10,000, with a maximum of two loans per member (or \$20,000). All loans will require a lien registration document for the member service address. The lien will be registered in the applicants service location county. Anyone receiving a loan will be required to be on our load management program and have a load control receiver installed. For Level 3 loans, a full credit check is required and could impact your credit score.
