ELIGIBILITY CRITERIA

- ❖ New equipment must be installed on cooperative's lines and connected to PPCS load management system.
- ❖ Incentive not to exceed 20% of the cost of equipment.
- ❖ Incentives not allowed for a measure and a component of that measure. For example, if an air source heat pump has a variable speed blower motor, the air source heat pump qualifies for an incentive but not the variable speed blower motor.
- ❖ Incentives are in place through December 31, 2019. Funds are limited so submit required documentation as soon as possible.
- ❖ Required documentation must be submitted within 3 months of install date. If submitted after December 31, 2019, equipment will be considered for the incentive offered in 2020.
- ❖ Additional eligibility criteria may apply. Program is subject to change or cancellation without notice. Contact cooperative for details.
- ❖ **Required documentation** listed below must be submitted no later than 3 months after install date.
 - ✓ This incentive form
 - ✓ A copy of your receipt or invoice for each item
 - ✓ Documentation showing the equipment has been installed
